

Are you ready for CDS?

30th September 2022

The movement from making declarations in CHIEF to the Customs Declaration Service (CDS) is happening! Unlike CHIEF, all traders who import or export will need to be registered for the CDS.

Espace Europe are ready for the switch over which will begin for imports on 30th September, 2022.

Complete the following checklist to make sure you are ready too.

| 1 | Register for the Customs Declaration Service via your Government Gateway

| 4 | Create a new Direct Debit for your Duty Deferment Account (DDA) with HMRC specifically for CDS (do not cancel your CHIEF one just yet)

| 7 | Check your DDA has sufficient funds | <input type="checkbox"/> |
| 8 | Set up a CDS Cash Account if you feel the DDA does not have sufficient funds
